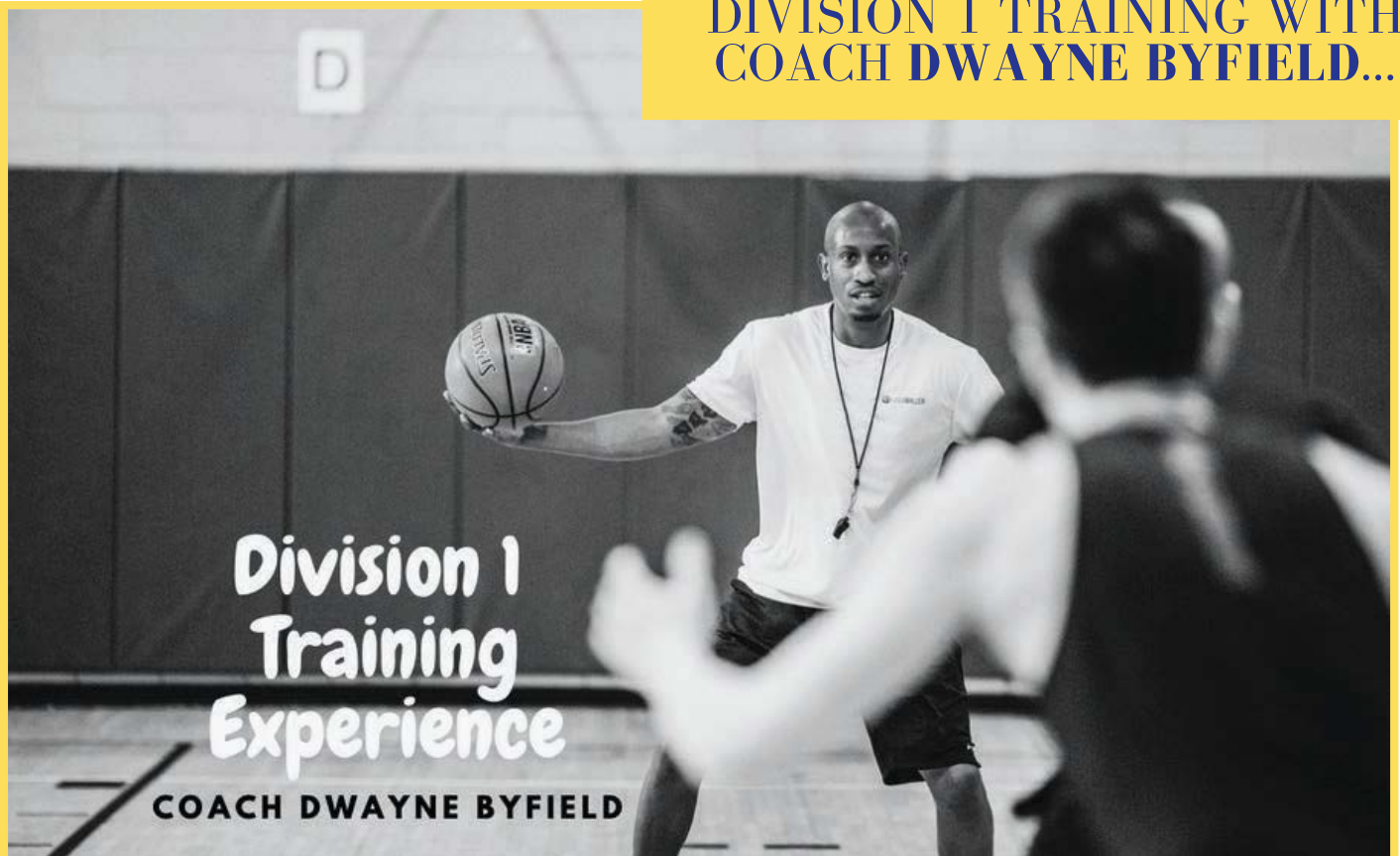

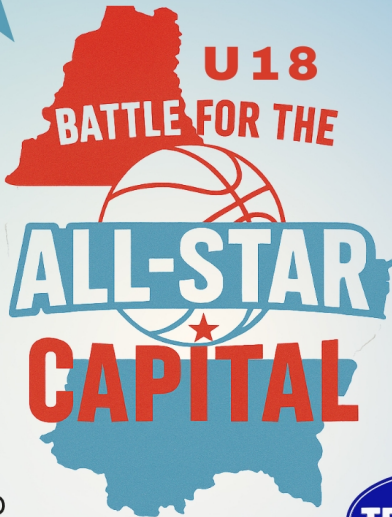

3x3 Luxembourg Tour



The 3x3 Luxembourg Tour is the first official 3x3 tour organized in Luxembourg, bringing this fast-paced and dynamic discipline to towns across the country.

The 2025 edition, marking the third year of the tour, runs from early June to mid-July, featuring four competitive stops in collaboration with local basketball clubs.

This year's series kicks off with Stop 1 – Lux City on June 7 at Centre sportif & scolaire Cents and concludes with Stop 4 – Esch Belval on July 12 at Place de l'Académie.
